Title: THE SUBSIDIARY APPROPRIATIONS ACT OF 2007-2008.

Section 51.: All guidelines and provisions in the Comprehensive UOSA Financial Responsibilities Act shall apply to all funds appropriated in this act.

Section 52.: The fiscal year for the accounts listed in Section 3 to Section 50 shall be July 1, 2007 to May 9, 2008.

Section 53.: All unspent money remaining in all accounts that received appropriations from UOSA last fiscal year shall revert to the UOSA General Account after May 9, 2008 and the remaining appropriations shall be canceled.

Section 54.: This act is hereby enacted.

Section 55.: This act shall become effective when passed in accordance with the UOSA Constitution.
