AS INTRODUCED

An act establishing an ad-hoc emergency allocation committee in both the Undergraduate Student Congress and Graduate Student Senate.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

**SECTION 1:** This act shall be known and may be cited as the Ad-Hoc Emergency Allocation Committee Act.

**SECTION 2:** PURPOSE: The purpose of this Act is to establish an ad-hoc emergency allocation committee in both the Undergraduate Student Congress and the Graduate Student Senate.

**SECTION 3:** CREATION: The Legislative Branch hereby establishes an ad-hoc committee of both the Undergraduate Student Congress and the Graduate Student Senate, to be appointed and convened as soon as is possible, and to consist of three (3) Undergraduate Student Congress members and three (3) Graduate Student Senators.

**SECTION 4:** CHARGE: The committee shall be charged with a complete review of the emergency budgetary process as stipulated by Title XII, Chapter 4, Section 30 in the UOSA Code. After a full review, the committee may be authors to legislation in relation to amending or reforming Title XII, Chapter 4, Section 30, to be introduced in both Houses for consideration.

**SECTION 5:** LEADERSHIP: The ad-hoc emergency allocation committee shall be co-chaired by one (1) Undergraduate and one (1) Graduate as selected by the committee members.

**SECTION 6:** PURVIEW: The purview of the ad-hoc emergency allocation committee shall be limited to the emergency allocation process. No other budgetary processes shall fall under the purview of the committee.

**SECTION 7:** DISSOLUTION: The ad-hoc emergency allocation committee may be dissolved by either an act of both houses or by the unanimous vote of the


committee members, such a vote must be communicated, during a regular meeting to both Houses.

**SECTION 8:** This act shall be effective when passed and signed in accordance with the UOSA Constitution.


