CONGRESSIONAL BILL NO. 820710

AS INTRODUCED

An act relating to finance; amending the UOSACA Title 12, Chapter 4, Section 23, which concerns the administrative districts of the UOSA; striking the Latino Greek Council as an administrative district of UOSA; amending the UOSACA Title 12, Chapter 5, Section 33, which concerns positions receiving a stipend; striking the Latino Greek Council as a position receiving a stipend; clarifying compensation periods; providing for short title providing codification; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

**Section 1:** This act shall be known and referred to as the “Stidham-Ward Financial Responsibility and Efficiency Reform” Act of 2009.

**Section 2:** AMENDATORY: Title 12, Chapter 4, Section 23 (a) of the UOSACA is hereby amended as follows (strikethrough indicating deletions and underline indicating additions):

**Section 23. Administrative Districts of the UOSA**

**a. Categories**

Organizations must fit into one of these three categories to be considered an Administrative Division of UOSA: Government: Organizations that collectively serve as student government for the entire student body without significant duplication. Residential: Organizations that collectively represent every student through their residences without significant duplication. Funding is provided for Housing Center Student Association, Interfraternity Council, National Pan-Hellenic Council, Panhellenic Council, and Multicultural Greek Council, ~~and Latino Greek Council~~. No additional funding will be distributed to separate entities (houses/floors/chapters) of these organizations. Campus Activities: Organizations that represents s and serves e every student through campus-wide activities aimed at improving student life on campus without significant duplication. An organization that falls under the Campus Activities category may not represent a particular ~~See~~ section of the student body, rather it must represent the entire student body. All

programming sponsored by that organization must be funded as a whole. The Chair (President) of the organization shall have discretion in allocating these funds.

**Section 3:** AMENDATORY: Title 12, Chapter 5, Section 33 of the UOSACA is hereby amended as follows (strikethrough indicating deletions and underline indicating additions):

**Section 33. Positions Receiving a Salary/Stipend**

The following positions shall receive a salary/stipend:

Associates of General Councils: \$11.00 x 50 hours/week x 34 weeks

Campus Activities Council Chair: \$365/month ~~Fall & Spring, \$250/month Summer~~

Chair of Congress: \$365/month ~~Fall and Spring, \$250/month, Summer~~

Chair of Senate: \$365/month ~~Fall and Spring, \$250/month, Summer~~

Election Board Members: 5 individuals per election, \$40 x 5 persons x 2 general elections

Election Chair: \$500/Spring General Election, \$200/Fall General Election

Election Poll Operators: 20 individuals per election, \$20 x 20 persons x 2 general elections

General Counsel: \$12.00 x 25 hours/week x 48 weeks

Housing Center Student Association President: \$290/month/~~Fall and Spring,~~

~~\$175/month/Summer~~

Interfraternity Council President: \$290/month/~~Fall and Spring~~

~~Latino Greek Council: \$290/month/Fall and Spring~~

Multicultural Greek Council: \$290/month/~~Fall and Spring~~

Coordinator of the Student Organization Resource Office: [minimum wage] x 10 hours/week ~~Fall and Spring~~

**All salaried and stipend positions listed within this section, Section 33, shall be compensated monthly with compensation periods beginning September 1<sup>st</sup>, and perpetuating monthly through April 30<sup>th</sup>, of the same academic year, except the positions of UOSA President, UOSA Vice President, Chair of Congress, Chair of Senate, Campus Activities Council Chair, and Housing Center Student Association President, which shall terminate employment and compensation May 31<sup>st</sup> of the same academic year.**

Any position not enumerated above shall not receive a salary/stipend.

**a. Traffic Court Justices**

The Traffic Court Justices are appointed at minimum wage, but not funded by UOSA; the positions are reimbursed through the Parking and Transit Office. *Stipends and Salaries Act of 2003; Congressional Bill No. 680704 and Senate Bill No. GF02-40, Sec. 6.*

**Section 4:** This act shall be effective when passed and signed in accordance with the UOSA Constitution and when November 1, 2009, shall have occurred.
