**Title:** THE ADMINISTRATIVE APPROPRIATIONS ACT of 2007

**Section 1:** This act shall be known and may be cited as THE ADMINISTRATIVE ORGANIZATIONS APPROPRIATIONS ACT OF JANUARY 1, 2007 TO JUNE 30, 2007.

**Section 2:** The purpose of this act is to appropriate the funds of the University of Oklahoma Student Association to the branches and organizations mentioned within.

**Section 22:** All guidelines and provisions in the Comprehensive UOSA Financial Responsibilities Act shall apply to all funds appropriated in this act.

**Section 23:** The fiscal year for all accounts listed shall be January 1, 2007 to June 31, 2007.

**Section 24:** All unspent money remaining in all accounts that received appropriations from UOSA last fiscal year shall revert to the UOSA General Account and the remaining appropriations shall be canceled on June 31, 2007.

**Section 25:** All previous acts in conflict with this act are hereby repealed.

**Section 26:** This act is hereby enacted.

**Section 27:** This act shall become effective when passed in accordance with the UOSA Constitution.


