Title: THE STUDENT ORGANIZATIONS APPROPRIATIONS ACT OF SPRING 2007.

Section 1.: This act shall also be known and may be cited as THE STUDENT ORGANIZATIONS APPROPRIATIONS ACT OF July 1, 2008 TO MAY 8, 2009.
