BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

**Section 1:** This act shall be known and may be cited as the 2008 Fall General Election Board and Staff Compensation Act.

**Section 2:** PURPOSE: The purpose of this Act is to appropriately compensate for the services that were performed for the Fall Election

**Section 3:** APPROPRIATION: Based on the statutory compensation, the following amounts are here by allocated:
