AN ACT ADVISING AND CONSENTING TO THE ALLOCATIONS
REGARDING THE CONOCO STUDENT LEADERSHIP WING AND
UNION STORAGE FACILITIES; AND PROVIDING FOR EFFECTIVE
DATE.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT
ASSOCIATION:

Section 1: The purpose of this act is inherent in the title.
